

# The Front Archery Liability Waiver

## The Front Archery, LLC Outdoors Participant Agreement, Release, and Assumption of Risk

On behalf of myself, my children, my parents, my heirs, assigns, personal representatives, AND estate. and in consideration of the services provided by The Front Archery, LLC, its agents, owners, officers, affiliates, volunteers, participants, employees, AND all other persons or entities acting in any capacity on its behalf (hereinafter collectively referred to as "The Front Archery"), I hereby agree to release, indemnify, and discharge The Front Archery as follows: Please initial each paragraph below:

\_\_\_\_ 1. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless The Front Archery from any and all claims, demands, or causes of actions which arise in any way from my activities at The Front Archery events, including any such claims, demands, or causes of action alleging negligent acts or omissions by The Front Archery.

\_\_\_\_ 2. I acknowledge that activities at The Front Archery events entail known AS WELL AS unanticipated risks that may result in physical AND/OR emotional injury, death, paralysis, or damage to myself, my property, or third parties. I further acknowledge that trampoline usage exposes participants to occasional cuts and bruises, and may expose users to more serious risks and injuries as well. I acknowledge that some of these more serious risks include, but are not limited to: falling off of the equipment; sprained or broken wrists and/or ankles; exhaustion; and other more serious injuries.

\_\_\_\_ 3. I expressly agree and promise to accept and assume all of the risks existing in this activity as described in paragraph 2 above. My participation in The Front Archery activities is purely voluntary, and I elect to participate in those activities in spite of the risks. I further expressly agree that I will pay for the cost of medical assistance should my activities at a The Front Archery event require such services.

\_\_\_\_ 4. I acknowledge that I may be injured by the actions of other participants who are also using The Front Archery equipment, and I agree to release, indemnify, and discharge The Front Archery for any injury or damages I incur that are caused or contributed to by another participant or participants.

\_\_\_\_ 5. I certify that I have adequate personal insurance to cover possible damage or injury that may occur to me OR THAT I MAY CAUSE TO SOMEONE ELSE while at The Front Archery events, or, IN THE ALTERNATIVE, I agree to bear the costs of such injury or damage myself. I further expressly agree to assume the risk of injury or aggravation of injury resulting from any preexisting medical or physical condition that I may have, both known and unknown.

\_\_\_\_ 6. In the event that there is any litigation between myself and The Front Archery, I agree that the only venue for such litigation will be in the state of Utah and further agree that the substantive law of Utah shall apply in such proceedings, regardless of the choice of law rules of another state. I further agree that should The Front Archery be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold The Front Archery harmless for all such fees and costs.

\_\_\_\_ 7. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

\_\_\_\_ 8. INTEGRATION CLAUSE. I acknowledge that this agreement represents the entire understanding respecting the consequences of my activities at a The Front Archery event that exists between myself and The Front Archery. I further acknowledge that all preexisting agreements, subsequent course of performance, or purported oral modification of the terms of this agreement that purport to establish different consequences for my activities at a The Front Archery event null and void.

\_\_\_\_ 9. By the very nature of the Activity "Archery" carries a risk of physical injury. I acknowledge that Archery Equipment and targets are available for use at The Front Archery event and also carry a risk of physical injury. No matter how careful the shooter/participant is, no matter how many spotters or referees are used, no matter what surface exists, the risk CANNOT be eliminated. Risk can be reduced but never eliminated. The risk of injury includes minor injuries, such as bruises, cuts, sprains, and more serious injuries such as broken bones, dislocations and muscle pulls. The risk also includes catastrophic injuries such as permanent paralysis or even death from landings or falls on the back, neck or head. By signing this waiver and initialing each paragraph you understand these risks.

By signing this waiver and initialing each paragraph, I agree to follow all safety standards and rules and agree to respect the safety of others while engaging in activities at a The Front Archery I Event. I also acknowledge that if I am hurt, if I hurt someone else, AND/OR property is damaged during my participation in activities at a The Front Archery Event, I have waived my rights to maintain a lawsuit against The Front Archery for liability or contribution if the injury or activity is covered by this Liability Waiver. I have read this Liability Waiver, and I agree to be bound by the terms therein.

PARENT OR GUARDIAN LIABILITY WAIVER ON BEHALF OF MINOR: I certify that I am the parent or legal guardian of all below listed minors, and that I have read this Liability Waiver. I agree ON BEHALF OF the below-referenced minor(s) to be legally bound by the Liability Waiver's terms and conditions. I further agree to be legally bound MYSELF by the Liability Waiver's provisions and to indemnify and hold harmless The Front Archery for any claims I may have against The Front Archery arising from the below referenced minors' possible injuries or liabilities. I further agree that if it is determined that I AM NOT the parent or legal guardian of the above-referenced minor, I will PERSONALLY INDEMNIFY The Front Archery for any potential liability or loss arising from the below-referenced minors' participation in activities at a The Front Archery Event.
